Encore Relationship Rewards are disclosed in the Rewards section of the billing statement for the card number provided at the time of enrollment. Encore Relationship Rewards can also be viewed by logging in to your account at www.usrelationshiprewards.com/login. Relationship Rewards earned on net transaction volume are capped at \$240 Cash Back per month and are subject to the Rewards Program Rules. Business accounts must remain open and in good standing to remain enrolled. We reserve the right to change or cancel the program at any time.
